Our Portcreek Elms survive!

In 2004 we planted a number of white elm trees at Portcreek west of Anchorage Park estate.

You will have seen the extensive flood protection work going on recently in that area. We were worried that they might have ridden roughshod over these and a few other hedging shrubs we had planted.

Now they have finished it's possible to check and confirm that the elms were protected.

There is a large area of bare earth for which there is a planting plan following the sea defence work. However, because of the inclement weather, the ground is so saturated the contractors have been unable to get onto site. The area is scheduled to become an orchard meadow. Some of the planting will be left so that Portsmouth CC can run a community planting event. When details are available we can let members know.

Most of the sea dredged aggregate that come into Langstone Harbour is brought in by the vessels 'Arco Dee' or 'City of Chichester'. A new vessel is expected to be brought into use in the spring or early summer to supplement current landings.

The commercial harbour dues for this activity are important for the sustainability of the harbour and also tend to reduce road traffic deliveries into our area. Recent bad weather has reduced dredging leading to the need to use road to get aggregate to development sites in Portsmouth & Havant.

Kendall's Wharf Development

The on-going saga of the extension of Kendall's aggregate wharf may now make some progress as Natural England have approved a plan that will form part of the environmental mitigation for the loss of mud habitat. This will involve moving some Tudor Sailing Club moorings off the mud to a pontoon. This will probably facilitate the submission of a new or revised planning application.

Hayling Billy Trail Repairs

The section of the Billy Trail which was damaged in the February 2014 storms has been repaired and the whole path is now open to the public.

110 m of timber revetment has been installed to repair the path and secure the communication cables running beneath it. This work was funded by Hampshire County Council.

Are we losing our marine life?

A public meeting was held in January at the Eastney Cruising Association to discuss the deterioration of marine life in Langstone Harbour, mainly focusing on an apparent decline in fish stocks. There was general agreement that marine life has been in decline for several decades, but no-one seems to have any hard data or explanations. At a more recent meeting, Wes Smith from the RSPB explained that they have started to do annual fish surveys to better understand the breeding performance of birds in the harbour, with Little Terns particularly in mind, and they now have three years' worth of data. Fishermen have no shortage of anecdotal evidence relating to the disappearance of

bass, oysters, flounder and sand eels for example. Until quite recently, the pools under Langstone bridge at low tide were an easy place to observe sponges, sea-squirts and other static marine life. (OK, so maybe it's in Chichester Harbour). The picture shows a candy-striped flatworm and lightbulb sea-squirts, taken in June 2005. You would be very lucky to see these now, thanks to the repeated activities of bait-diggers and crab collectors.

Fairly, or otherwise, Southern Water took much of the flak at the meeting, since partially treated waste water is discharged into the harbour during periods of heavy rainfall, though their new Surface Water Separation Scheme for part of Portsea Is-

new Surface Water Separation Scheme for part of Portsea Island has helped to reduce this problem. It is unlikely that any more major improvements will occur

Although the local expertise exists to analyse any existing evidence and gather new data, there seems to be a lack of joined-up thinking, and probably funding, on how best to go about the task.
